I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." To the Honorable the Members of the Senate and of the House of Representatives of the State of South Carolina

Your petitioners respectfully Sheweth

That Matthew Dickson Senior a Citizen of Pendleton District is about Ninety five years of age, and that he has resided in this District for about Thirty five years during which time he has supported the reputation of a highly respected Citizen, and of a man who rendered many important services in this State in the Cause of liberty during the Revolutionary War – although we did not Witness his efforts at that period, we are bound from the annexed testimony, as well as from various statements to believe that he was an indefatigable Whig, his neighbors has for Several years past owing to his property in great age advised him to apply to the Legislature of this State for a Pension – he however seemed indignant at the thought of being a charge to his Country as he preferred to use his own language, the liberty that he and his posterity enjoyed, above all the toils that he encountered during the Struggle – he has however survived longer than he from the course of nature could have expected, and is at present reduced to such a state of poverty and infirmity that he has expressed a willingness to become a Subject of his Country's bounty - Your Petitioners offer to your Honorable bodies, his great age together with his blindness, deafness and the shattered Situation of his mind and money, as an apology for the mode of interference as he is at this time entirely incompetent to act for himself – all the Estate that he is possessed of consists of an old one out plantation entirely out of repair and of but little Value and a few head of Cattle and Hogs – Your petitioners therefore humbly pray that your Honorable bodies will place the said Matthew Dickson Senior upon the pension Roll, and that you permit him to draw for a year or two that has passed and your Petitioners will ever pray &c &c &c &c
