Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.1

Know all men by these Presents that I John Armstrong of the County of Botetourt & State of Virginia have Authorized & empowered & do by these Present Authorize & Empower Colonel William Hill to receive a Negro Due to me as Bounty from the State of South Carolina in consideration of military Services by me performed under the command of Lieutenant Colonel John Thomas in the State Regiment of Dragoons; & in case no Negro can be procured as a recompense for said Services, that then the said Colonel William Hill is hereby empowered to receive for me Whatever equivalent the State shall offer; In witness hereof I have hereunto set my hand & seal this 12th day of May 1783 & in the 7th year of the Independence of America.
