Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." To the Honorable Senate & House of Representatives of the State of South Carolina your Petitioner Humbly Sheweth that her Husband Philemon Parton [sic] were a Soldier in the Militia in the Revolutionary War on the liberty Side he were Drafted in Orange County North Carolina and were sent on to this State to the Cheraw Hills under Captain William Jones² and served a three months Tour then Returned Home to North Carolina and served Two Tours of three months Each after he got home from South Carolina in Suppressing the Tories he has been Dead six years in July last & Your Petitioner our left in a Very Low Desolate Situation Very old and infirm all the Property I Possess are my bed and furniture with my Clothes and a few Cooking Utensils and Water Vessels and one Sitting Chair I am not able to do Scarcely anything but knit which is the only means of my Support except what the Neighbors have been good enough to Give & your Petitioner humbly Prayeth that your Honorable Bodies will take her case into Consideration and give her what you may think in your Judgments She Merits & your Petitioner will Ever pray – given under my hand this 21st of November 1831 Test
