[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." To the Honorable the President of the Senate and the Honorable Members of the same
The Humble Petition of William Armstrong Sheweth; that your petitioner entered the service of
his country at the commencement of the Revolutionary war as a private soldier in Captain
Benjamin Kilgore's Company of militia Cavalry, General Williamson's [Andrew Williamson's]
Brigade. That your petitioner was on the Cherokee expedition in said Brigade in the year 1776.
Was in three hard-fought battles one of which is known by the name of the ring-fight [August 12,
1776]². That after the termination of this expedition your petitioner joined Captain Porter's
Company of North Carolina militia and was at the battle of Ramseur's Mill [June 20, 1780]
where he was wounded with two Balls one of which severely shattered his right leg, the other
was received in his left shoulder and broke his collarbone. That your petitioner was in the
service of his Country until the time of his being wounded. That when your petitioner entered
the service of the State for the Cherokee expedition he was promised by his commanding officer
a bounty of six hundred and forty acres of land, which he has never received, nor has he ever
received a cent from the state for his services and sufferings.

That the wounds received by your petitioner have disabled him from making a competent provision for his family; the effect of his wounds are still severely felt after the lapse of more than forty years, that your petitioner is now in the sixty-ninth year of his age, and is in indigent circumstances needing the support of his country: Your petitioner therefore humbly prays your Honorable body to appreciate the motives & the value of his sufferings and to make suitable provision for him according to his age, his infirmities and his indigence – Your petitioner prays that he May receive a commutation for his bounty in land, that he may be placed on the pension

To the Honorable the Speaker and Members of the House of Representatives of the State of South Carolina

The humble petition of Elizabeth Armstrong Sheweth, that her late husband William Armstrong who lately departed this life, was a pensioner of this State for some years before his death, that he died insolvent in October 1823 leaving your petitioner his widow aged infirm and helpless, that she is nearly seventy years of age and totally incapable of gaining a livelihood by industry. She therefore prays that she may be allowed the continuation of the pension allowed her husband as a support for her during her few remaining years, and that it be allowed her from the time of the death of her said husband.

And your petitioner will ever pray &c.

Respectfully Report

That having had the same under consideration and find that her late Husband was a Pensioner and paid up to the 1st of March 1823 as a revolutionary Soldier, Therefore recommend to this house that the said Elizabeth Armstrong be placed on the Pension list during her Widowhood, at \$60 per annum December 1825
