[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.1

State South Carolina Lancaster District –

Personally came before me Alexander Douglas and after being duly Sworn, deposeth & saith on oath that he served as an enlisted Soldier in the United States Service under the command of Colonel William Thompson [William Thomson] of the third Regiment of South Carolina Line that he enlisted in the year 1775 for the term of sixteen months that he was regularly Discharged that afterwards he entered in Captain Bivins<sup>2</sup> Company of the second Battalion of Minute Me[n] under the command of Colonel John Stewart of the State of Georgia faithfully Served his tour of enlistment & was regularly discharged – this deponent further saith that from the fatigue and Exposure to all the difficulties of the Snowy Campaign<sup>3</sup> he was attacked with fevers which fell into his Leg, & often endangered his Life & rendered him unable to work for Several years past, that he is [in] indigent Circumstances & unable to support his five Motherless Children of which four are females.

To the Honorable the Speaker & other Members of the house of Representatives –

The petition of Alexander Douglas Humbly Sheweth that at an early period of the Revolutionary war with Great Britain – he entered the Service of the United States as an Enlisted Soldier, that he Served his Tour of enlistment in the State of South Carolina in Captain Eli Kershaw's Company of Rangers under the command of Colonel William Thompson And Exposed to all the perils & dangers of the war – that after being regularly Discharged the Service in this State he enlisted in the Second Battalion of Minute Men in the State of Georgia in Captain Bivins Company under the command of Colonel Jon Stewart Served his term of enlistment & from being exposed & fatigued of Complaints Contracted Disease which he never recovered – And that though [sic through] misfortune is reduced to indigent Circumstances & from the Ravages of Age is Rendered unable to Support himself & five Motherless Children of which four are females – Your petitioner prays your Honorable body to take his Case in consideration & grant such relief as you in your wisdom May deem Meet 4 & your petitioner will ever pray –

Johnson noted that even at that time the word "meet" was rarely so used. It must have become fairly popular in South Carolina in the early 1800's, however, as it appears in many petitions submitted to the SC Legislature.

Personally appeared before me John Neely<sup>5</sup> who made oath that the said Alexander Douglass [sic] was a messmate with Deponent in the year 1775 or 1776 (as well as he remembers), in the Company of Captain Eli Kershaw under the command of Colonel William Thomson, that he further does not recollect anything about him, or what became of him. And that he lived about two years (about three years ago) near the said Alexander Douglass that he was in, then & he believes he is now, very low circumstances and that he has Just been in the neighborhood of the said Douglass and was there informed that he was still in the same needy circumstances.
