Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the Honorable the Speaker and Members of the House of Representatives of the State of South Carolina

The Humble petition of Edward Threewits Sheweth

That your petitioner was wounded during the American Revolutionary war, in defense of his Country – That he had two Balls Shot into his shoulder which has frequently prevented his working. That about the year 1789 or 90 your petitioner was allowed an annuity by the Legislature, which annuity he received for the Term of five Years – And that in the year 1794 your petitioner removed to the State of Tennessee (leaving one Year's annuity then due him) in which State your petitioner has since resided. Your petitioner further Sheweth unto your Honorable body that in consequence of the wound which your petitioner received, he has been unable to use that arm in work.

Your petitioner is poor and not able to procure his living by Labor – That he is now fifty eight Years of age. Your petitioner prays that your Honorable body will take his case into consideration & grant such relief in the premises as to your Honorable body shall seem meet. And your [petitioner] shall ever pray &c

² In Samuel Johnson's Dictionary of 1755, the first definition of the word "meet" he gives is "Fit; proper...". Johnson noted that even at that time the word "meet" was rarely so used. It must have become fairly popular in South Carolina in the early 1800's, however, as it appears in many petitions submitted to the SC Legislature.

To the Honorable the House of Representatives of the State of South Carolina

The Humble petition of Edward Threewits Shows, That during the American Revolutionary War your petitioner was shot & wounded by the Tories and that he has since remained a cripple – That your Honorable body about the year 1789 or 1790 placed your petitioner on the pension list and continued to receive his pension until the year 1794 That in this year your petitioner being sickly poor and his wound continuing painful and as yet unhealed your petitioner removed to the State of Tennessee – That after his removal he suffered much from his wounds and was too poor to return for his pay until the year 1819 when he was again placed on the pension list. Your petitioner further shows unto your Honorable body that he has for many years expended money amounting to at least one hundred pounds for medical aid and assistance furnished, on account of the wound received – He therefore prays your Honorable body that Appropriation be made your petitioner for his pension from the year 1790, when he received his last pension, to the year 1819 when he was again placed on the pension list.

To the Honorable the Legislature of South Carolina

The Humble petition of Edward Threewits Sheweth that he was engaged as a militia man during the Revolutionary war in the service of this State under the command of Captain Maurice Murphy [sic, Malachi Murphy, Jr.], and during the performance of his duty in the defense of his country he was wounded in his shoulder at Brown's Mill [April 17, 1781]³ in Marlborough District by two Balls, that in consequence of said wound he was disabled & prevented from obtaining his livelihood by his own labor & upon these facts being presented to the Legislature he was placed on Pension Roll at the rates of twenty-two dollars & thirty cents or thereabouts about the year 1788 – That he received from the Treasurer the said sum for several years until the year 1794 at which time his said Pension was stopped and withheld from him but for what particular reasons your Petitioner is unable to state. That afterwards about the year 1796 finding that he was residing in a sickly place on Pee Dee River he removed to the State of Tennessee. That afterwards by the act of 1816 he was placed on the Pension roll of this State at the rate of sixty dollars per annum, that he has received only three years pension since 1816 and that there are still arrears due to him on that account. [Paper damaged and text missing] petitioner therefore prays your Honorable Body to cause the arrears of Pension from 1794 up to the time at which he received his increase of pension to be paid to him and if to your Honorable body it should appear right and proper he hopes he may [be] allowed also the interest on the same as he applied several times during the said period by his friends but never received the same.

Your Petitioner begs leave to state that his infirmities proceeding from the said wound has in addition to the effects of old age rendered his left arm altogether useless to him he is now old & poor & having devoted himself to his Country when young & active, and been disabled in its service he fondly trusts he will not now appeal to the liberality & Justice of the Legislature in vain.

He asked only what your Honorable Body have given to others and he will ever pray &c Columbia December 4th, 1822

I certify that the name of Edward Threewits appears on the pension list, and from the Books in my Office appears to have received the annuity allowed viz., \$21.42 until the first of March 1785 from which time until the first of March 1819 I cannot find that he has received anything on that account when he was again placed on the pension list at the rate of \$60 per annum, which he has continued to receive from that time 1 March 1819.
