The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.1

To the Honorable the President & other members of the Senate, the Speaker & other Members of the House of Representatives

The petition of John Nicoll most humbly Sheweth that your petitioner engaged in the service of his Country as a Lieutenant in the Company commanded by Captain Barry in Colonel John Thomas's Regiment Spartanburg County and continued in the said company until May 1781 when your Petitioner was attacked by a party of Loyalist, and literally cut to pieces, so much hurt by his wounds & the consequent loss of blood he lay helpless for the term of ten days and lost on the same occasion all his property to the amount of One hundred & fifty Pounds; and was ultimately despaired of his senses for a long period of time. That your petitioner also deposited in the loan office a quantity of paper money which had been put into circulation by the British officers which was counterfeit: that he received a certificate therefore; and deposited the same in the office of the Secretary of State which your petitioner has never received it being lost. Your petitioner was a soldier for four years; that he is now 82 years of age and stands in need of assistance. He therefore prays your Honorable body to make such provision for him as he may be deemed worthy of

South Carolina Spartanburg District I do Certify that from the commencement to the close of the Revolutionary War, I was well acquainted with Mr. John Nicoll.

In the year 1775, when British Tyranny had encroached on our rights & liberties, & our Country compelled to appeal to the GoD [sic] of battles, he was amongst the first Citizens of Spartan Regiment (then commanded by Colonel John Thomas) who raised the standard of Independence & marched to the tented field with the rank of Lieutenant, in Captain Andrew Barry's Company, fearlessly pledging his life, & all that was dear to him in defense of his country.

Through the whole of our revolutionary struggle Lieutenant Nicoll continued a firm patriot. His hospitality to our suffering troops were only limited by his ability to supply their wants, which he did without remuneration, until near the close of the War: the Tories deprived him, not only of the pleasure, but the ability of feeding & comforting the war worn soldier, by

Burning, Plundering, & carrying away his property, and at the same time severely wounded him in the head with a Sword. Lieutenant Nicoll is now upwards of eighty years old, & by his losses in the Revolutionary War, & his misfortunes since, he is reduced to extreme poverty

We whose names are hereunto Subscribed do certify and affirm that John Nicoll the present petitioner Served as a Lieutenant in the Revolutionary war in Captain Andrew Berry's company Colonel John Thomas's Regiment: And having Sustained severe losses and damages there from, he hopes the Legislature will take the same into consideration, as the amount of the spoliations are here accurately named, which said transactions happened and on Damages done on the 10<sup>th</sup> day of May 1781 by Colonel William Young Commander of a Tory Scout, further said Nicoll received a severe wound on the head with a sword by the said Scout which rendered him

incapable of service for a considerable time and now is Eighty-three years old and reduced to extreme poverty
