Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

The Humble petition of John Dosier [sic] Sheweth

That he is now a pensioner for Revolutionary services, and being desirous of moving to the Western Country, prays that he may be authorized to draw his pension – one year in advance and his name may then be stricken from the Role of Pensioners – and your Petitioner will pray S/ John Dosie [sic], his mark

[Note: The petitioner's prayer was granted and his name was stricken from the roll of South Carolina revolutionary war pensioners. Unfortunately, any petition the veteran may have filed initially seeking to be included among the South Carolina Revolutionary War pensioners is not contained in the file. Consequently we have no description of his services. The only veteran named John Dozier that I could find listed on the roster prepared by JD Lewis is listed as a Captain in the St. David's Parish Volunteers in 1775 as well as a Captain in the Britton's Neck Company in 1780. Whether or not this is the same man as listed by JD Lewis cannot be determined from the documents in this file. See,
