Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

[Transcribers Note: This individual did not file a claim for service during the Revolutionary War. I have included a transcript of a document in this file which supplies an important bit of information regarding the death of Major William Benison.²]

[p 3: This consists of the listing of the various items of provisions supplied by the claimant dating the taking of the provisions on February 12th, 1782. The account was certified by both Peter Horry as then Lt. Col. and Francis Marion as Brigadier General. The relevant portions of the listing read as follows:

"The Public Dr. for a Months stay of Colonel Peter Horry's Cavalry under the Command of Major William Benson} 1782 Feb^y 12th"]

State of South Carolina

Personally appeared John Drake who maketh Oath that the within Account to the Best of his Knowledge and Belief is Just and True, and no part thereof has been received. He further declares that he could not obtain a Certificate from the Commanding Officer Major William Benson [sic] whose party being Surprised by the Enemy, the said Major was killed. Sworn to before me this 23rd May 1783.
