Humbly Sheweth -

That your petitioner's Father was killed in the Defense of his Country at the Fish dam Ford [November 9, 1780]<sup>3</sup> under the Command of General Sumpter [Brigadier General Thomas Sumter] – that your Petitioner's Mother died in a short time after. Your Petitioner being Bound out and without friends, no application was ever made to draw his Annuity which was due him from the State, your Petitioner therefore begs your Honorable Body to take his case into consideration & grant him such relief as in your wisdom Shall Seem Meet,<sup>4</sup> and in duty bound your Petitioner will ever Pray
