I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]



To the Honorable the Representatives of the State of South Carolina

The Humble petition of Thomas Durant Senior a Resident of the District of Horry, respectfully Sheweth that in the beginning of the Revolutionary War, he entered as a soldier in a company of independent Volunteers, foot Rangers or Riflemen called "Governor Rutledge's Life Guard" commanded by Captain John Alston [John Allston] and Lieutenants Withers and Coachmen [James Coachmen], that under their command he went to Sullivan's Island when the British Ships of War lay at the end of the Island and burnt the pest [?] House and brought off some of the British Sailors prisoners – When the British fleet and Army under Clinton [Henry Clinton] and Parker invaded the State he was on Sullivan's Island and on Haddrell's Point when the Officers resigned their Commissions. He then went with Colonel Daniel Horry who commanded a Regiment of Horse to the Continental Army commanded by General Lincoln [Benjamin Lincoln] which lay in Purrysburg on the Savannah River – and then to Orangeburg under the command of Colonel McDonald [Archibald McDonald] and Major Hugh Horry. After the defeat of General Gates [Horatio Gates' defeat at the Battle of Camden, August 15-16, 1780], General Marion passed through the Settlement where I live with about 25 men – I voluntarily joined him and was under his command until the end of the War.

As your Petitioner kept no journal he cannot at this time recollect all the circumstances or fatigues he then encountered, He has been in two Battles one at Parkers ferry<sup>2</sup> near Charleston – the other on Waccamaw<sup>3</sup> – And is near 72 years of age – and from his age and infirmities, the pressure of the times and the [word too faint to discern] of his circumstances – he solicits your hands such relief as has been extended to others in similar circumstances.

Sheweth,

That by the act of your Honorable body in Fall term 1825 your petitioner's father Thomas Durrant [sic] was inscribed on the pension Roll for Services rendered in the War of American Independence, that this petitioner in behalf of herself and two old indigent and infirm Sisters, makes this her petition to your Honorable Assembly to grant an order on the Treasurer of the State to pay the amount of pension due at the date of her said father's death on the 27<sup>th</sup> day of February 1827 and your petitioner will ever Pray &c and she hereby Constitutes and appoints James Taylor of Sumter South Carolina in behalf of herself and two Sisters to receive the Balance of pensions aforesaid.

In witness whereof she has hereunto set her hand and seal this 29 day of October 1858 S/ Francis Graham, X her mark
