I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]



96 District} Personally came Michael Duval before me & made oath that the above Gray (trots & Cantors, Raising 7 years old 14 hands or upwards high Branded on the Mounting Shoulder M and on the Buttock D) that said Mare was taken from him by Jesse Johnson who said he was a Captain in Colonel Hammond's light Dragoons who gave the annexed Receipt that he impressed said Mare for the use of Colonel Hammond's said Dragoons, that said Mare has never been returned to him again nor any Satisfaction for the Same and that if ever he Received said Mare he will Account to the public for the same. – That said Mare is his just and absolute property Sworn to the 23<sup>rd</sup> of July 1783 before me
