Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

Petition of Henry Edwards praying to be placed on the pension list Pensions Granted

State of South Carolina

To the Honorable the President Speaker and members of the Senate House of Representatives of said State

The petition of Henry Edwards of Chesterfield district in the said State, respectfully Sheweth –

That your petitioner enlisted in the second Regiment, commanded by Colonel Francis Marion, soon after the commencement of the war of the Revolution, and continued in said Regiment, until the surrender of Charleston [Charleston South Carolina fell to the British on May 12, 1780]² when he escaped capture by [undeciphered word]³ himself and afterwards escaping from the City.

When the spirit of the country began to revive, your petitioner joined General Marion, and served with him in the militia service, until the end of the war, during which time – he was in the Battle of Quinby [Quinby's Bridge, July 17, 1781] and Eutaw [Eutaw Springs, September 8, 1781], at both of which he was wounded. At the first, in the lower part of the abdomen, and at the Last, by a ball in the breast, which was never extracted, and from which in his old age, he has experienced much pain and uneasiness.

[Undeciphered word]⁴ your petitioner, further shows unto your honorable body, that until lately his situation was not such as rendered assistance necessary – to his subsistence; for until recently he has been a healthy strong man, and chose rather to eat the bread of his own industry – than to live on the Charity of his Country. But being now seventy-three years of age, and disabled in a good degree from working, by the Rheumatism and the wound above mentioned, he feels himself constrained to ask, that assistance, which whilst he was able to labor, he was unwilling to receive. Your petitioner is advised that having been a soldier in the Continental Line, he is entitled to a pension under the act of Congress but he has no record of his service, and all who knew him as a soldier in the 2nd Regiment are gone – and on Looking about among the few of his contemporaries, who are alive, he finds only two or three & they only knew him as a militia man with Marion. Being therefore unable to establish his claim to the pension allowed by the General Government and having rendered some faithful service as a militia man, he now prays your honorable body, that he may be placed on the pension list whereby the Remnant of his days may be rendered from want & he will ever pray, &c
