Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

Philadelphia January 18th 1796

Sir having been Informed by a member of Congress that you are a Friend to the widow & fatherless I write in behalf of the widow and Daughter of the Late Joshua Faning Lieutenant of the Frigate *Randolp* [sic, *Randolph*]² that was blown up the Last war having Account of Money loaned³ by him to the State of South Carolina I beg you will transmit a Statement from your book in what Provision the State has made for the payment of her debts: and Please to Let me know In what Manner I must proceed to recover this money for the widow and the Daughter Molly Faning.

I am Sir your Very Humble Servant S/ James Swain in behalf of the widow and child
