[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

To the Honorable the Senate & House of Representatives of the State of South Carolina – The petition of Thomas Farmer Sheweth

That your Petitioner is one of a few surviving Sons of 76 who led the long pull – the tough pull & the successful pull for Liberty. That your petitioner did his duty in Marion's [Francis Marion's] brigade and elsewhere as your petitioner will be able to satisfy your Honorable body – That your petitioner is now in 85<sup>th</sup> year of his age – poor & Infirm, That age infirmity & want now paralyzes that hand which toiled for Liberty & has subdued that Spirit which stumbled not before the British foeman – to stand a humble supplicant in the winter of his old age before your liberal body – Praying to be placed on the bounty of the State as a pensioner & your petitioner will pray

The Humble Petition of Thomas Farmer

Sheweth, that he served during the Revolutionary war four or five years under General Marion, Colonel John Baxter's Regiment, under Captain Robert Baxter, and was under Captain Coffee at Bluford's defeat.<sup>3</sup> That he was honorably discharged at the end of the War, and now is reduced to the most indigent circumstances, and is 86 years old next January, and entirely incapable of walking, or doing anything for his livelihood, but is entirely dependent upon the charity of the world for his pittance of daily bread

Wherefore he prays your Honorable body to put him on the Pension List and in duty bound he will ever pray

The Petition of William Farmer for himself and the other heirs of Thomas Farmer deceased praying payment of arrears of pension

#### [p 18]

To the Honorable the Speaker and other members of the House of Representatives of the State of South Carolina

The humble petition of William Farmer of Harris County Georgia for himself and the heirs & legal Representatives of Thomas Farmer deceased (some of whom reside in South Carolina) respectfully Sheweth: That said Thomas Farmer deceased formerly of Richland District South Carolina, was one of the venerable Soldiers of the War of the Revolution and upon application to your Honorable Body, submitting the necessary proofs, he was placed on the Pension Roll of the State at the Session of December 1826. That he was paid on the 28<sup>th</sup> November 1827 his annuity up to March 1827 [sic] which was the last payment made to him: That said Thomas Farmer the aforesaid pensioner, & father of your petitioner, was then an aged and greatly afflicted man in his latter years and from having by an accident, had his Hip put out of place, he was unable to leave his house for the last 5 or 6 years of his life: That on Account of said affliction & infirmity he was prevented from attending at the office of the Treasury to

receive the annual pension: That he was taken once of [sic] by his family and that the arrears of pension has never been received by them. Wherefore respectfully referring your Honorable Body to the State Records in confirmation of the facts above stated & to the proof herewith submitted your petitioner prays for himself & the other heirs of said William Farmer that the said arrears of pension up to the day of his death on the 30<sup>th</sup> day of June 1832 be paid to them by the Treasurer of the State upon their producing to him the necessary proof of Identity usual in such matters – and your petitioner will ever pray &c

State of South Carolina Richland District} Personally appeared William Farmer who being duly sworn says that the facts as detailed in the Above petition are true as far as stated of his own knowledge & those based upon the information of said State Records he verily believes. Sworn to and subscribed this 7<sup>th</sup> day of August 1851

[p 24: In a petition dated November 25, 1852, William Farmer renewed his attempt to obtain the arrears of pension due his father at the time of his father's death. In this petition William makes reference to his (William) having removed to Georgia in October 1832; that his sister (not named) also removed to Georgia shortly thereafter leaving a brother in Richland District; that the brother died in 1837.]

[p 26: On November 25, 1852 in Richland District South Carolina James Jones gave testimony that he was a neighbor of Thomas Farmer; that he was present at Farmer's funeral; that he knows that Farmer died within 2 or 3 weeks of the birth of John Kelly the son of James and Mary Kelly who were also neighbors and whose family record shows that John Kelly was born on May 31, 1832; that Thomas Farmer died in June 1832, a fact he, the deponent, distinctly remembers. Jones signed his affidavit with his mark.]

[p 27: On November 25, 1852 in Richland District South Carolina Mary Kelly gave testimony restating the facts as testified by James Jones above. She signed her affidavit with her mark.]

[p 28: On November 29<sup>th</sup>, 1852 in Richland District South Carolina, James Kelley gave testimony that he was a neighbor of the late Thomas Farmer, a South Carolina pensioner; that he, Kelley, married a granddaughter of Thomas Farmer; that he was present at Farmer's funeral which took place about 3 weeks after the birth of deponent's son John Kelly on May 31, 1832; that the only children of Thomas Farmer still living are the Reverend William Farmer and Mrs. Sarah Honeycut, deponent's wife's father having died a few years after Thomas Farmer died.
