Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

[p 2: Printed form of indent No. 546 Book P dated March 27th, 1779 reciting in part as follows: "We the Commissioners of the Public Treasury, Do Certify, That we have received into the Treasury from a Free Negro man Joe who was the property of Doctor John Farquharson Fifteen hundred & ten Pounds [old South Carolina] Currency as a Loan to the State. The said Free Negro man Joe his Executors, Administrators or Assigns, will therefore be entitled to receive, and shall be paid at this office, the sum of one hundred & five Pounds 15/ [15 Shillings] on the 27th of March 1780 for one year's Interest, on the said Principal Sum of Fifteen hundred & ten pounds and the like Sum of one hundred & five Pounds on every 27th of April yearly, for each and every following year during the said Loan."]
