Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of South Carolina Sumter District To the Honorable the Speaker and Members of the House of Representatives of the State aforesaid

The petition of Elizabeth Flagler of the District and State aforesaid, Humbly Sheweth.

That John G Flagler deceased, late Husband of your petitioner volunteered in the Service of his country before properly recovered of a Severe [undeciphered word],² went on to the troops at Haddrell's Point and there died in the Service aforesaid, leaving your Petitioner and four Small Children in a distressed Situation, without the means of Ordinary Support, your petitioner therefore prays your Honorable body will take her Case into Serious Consideration, and grant her that patronage which to you, in your wisdom may Seem meet,³ and as in duty bound will ever pray.
