Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]


To the Honorable the Members of the Legislature of the said State

The Petition of John Fleming Senior Sheweth to your Honorable body that your Petitioner was a soldier in the Revolutionary War, that he served under the command of Colonel Joseph Taylor, and Captain Nathaniel Waller a three months tour in the year A.D. 1781 as the affidavit of James Godfrey herewith exhibited manifests –

Your Petitioner further begs leave to show that he is now between seventy & Eighty years of age, that he is poor, and [has] no possible means of support –

Your Petitioner therefore prays that he may be enrolled on the pension Roll, if to your Honorable body it seemeth meet,<sup>2</sup> & your Petitioner will ever pray

South Carolina Kershaw District Personally appeared Rawleigh Hammond<sup>3</sup> before me Samuel B Hammond who after being duly Sworn upon the holy Evangelists of Almighty God & saith that he saw John Fleming Cenr. [Senior] in the Camps in the year 1780 as near as he can recollect serving as a Militia [man] under the same Captain of himself which was William Gillom [probably Captain William Gilliam of the Granville County North Carolina militia] this

Johnson noted that even at that time the word "meet" was rarely so used. The humble petition of John Fleming Senior respectfully Sheweth, that he served in the Revolutionary War in defense of the Country in Several Companies. That he is now upwards of Eighty years old and in reduced to great Poverty & distress that owing to the death of a Number of his Compatriots he is [paper damaged and text missing] to procure certificates of all the time he served in the said War – That he also served and was present at the Capture of Fort Rugeley<sup>5</sup> on Graneye Quarter [Grannies Quarter Creek] in this State.

He therefore hopes that from the circumstances of his extreme old age and poverty (having no property of any Value except a few Cooper's Tools and a few Shoemakers' Tools) that he may be placed on the Pension List, and [undeciphered word] Petitioner Will ever Pray
