I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

In the House of Representatives January 22, 1791

The Committee on Mr. Ford's account for his Services as major in Colonel Roebuck's Regiment.

Report -

That on investigation they find that Mr. Ford had delivered his account to Colonel Anderson than a Commissioner authorized to receive the public's accounts and General Pickens [Andrew Pickens'] Brigade, that for want of the necessary Vouchers the Auditor General referred it to the Commissioners of disputed accounts who refused to pass it. That Mr. Ford took back his account from the Commissioners and had the proper Vouchers obtained, but on sending it again down to the Commissioner the person who carried it, lost or misplaced it on his way to Charleston so that Mr. Ford could never receive an Indent or any Satisfaction for Services –

Your Committee therefore being fully Satisfied of the truth of the facts and the justice of the claim, – recommend that the Commissioners of the Treasury be directed to issue an Indent to Mr. Ford for the Principal Sum of one hundred and fifteen pounds fourteen Shillings & three

pence Sterling with Interest thereon from the first day of April in the year 1783 – Resolved that this House do agree with the Report

Ordered that the Report and Resolution be sent to the Senate for concurrence By order of the House
