I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcripts "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

To the Honorable the President and Other members of the Senate of South Carolina. The respectful Memorial and petition of John Franklin, a resident citizen of the District of Chester for Forty five years and upwards, is hereby confidently submitted to your Honorable Body: - That your Memorial is an old man being Seventy eight years of age and upwards; - that in consequence of his said age and the many infirmities attendant thereon, he is become unable to Support himself in a comfortable degree: And therefore throws himself for protection on the kindness and friendship of a community, which has ever cheerfully fulfilled all claims on its gratitude. Your Memorial begs leave to State that he entered at an early period, into the Service of his country, in the most perilous times: – He served under Colonel Careuth<sup>2</sup> in the Cherokee war; - was with Colonel Farr at Drowning Creek in North Carolina<sup>3</sup> in Service against the Tories: – and served under Colonel Crawford<sup>4</sup> in the campaign at Wilmington State of North Carolina –; was an a regiment under Colonel John Thomas at the siege of Savannah,<sup>5</sup> and was generally in active service from the commencement to the termination of the Revolutionary war. For his youngest, best days thus employed and countless privations endured, his remuneration has been inconsiderable. But consoling himself in doing his utmost in every magnanimous Sacrifice and co-operation for the establishment of a glorious Liberty, which now protects, and may transmit comfort and blessing, to the latest prosperity, your Petitioner proposes his case to your wise consideration - that as an aged, helpless, and indigent Citizen, a suitable and customary relief and alleviation may be afforded. Your petitioner prays an examination of his claim to public friendship, and Submitting the necessary vouchers, Submit also his express wish
