Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

To his Excellency John Rutledge President &c of the Colony of South Carolina The Memorial of John Featherston, a Free Negro man

most Humbly Sheweth

That your Memorialist served on Board the Schooner *Defense*<sup>3</sup> Captain Simon Tuff [Simon Tufts] for the Space of Seven Months, and never received more than two months pay though often applied to said Captain for the Balance of my Wages, and obtained for answer to apply to your Excellency.

Your said Petitioner applied to your Excellency who was pleased to tell him for his Captain to come to him. He neither can get him to come or to satisfy that your Memorialist is the man & what there remains due.

Your said petitioner is in the Public Service for this two Months under the command of Captain Grimball, most humbly prays your Excellency will be pleased to take the premises into Consideration and Order such relief as shall in his Wisdom shall seem meet.<sup>4</sup>

Johnson noted that even at that time the word "meet" was rarely so used. It must have become fairly popular in South Carolina in the early 1800's, however, as it appears in many petitions submitted to the SC Legislature.
