This may certify that Lucretia Freeman did in my presence sign the above Order, that she now resides in the County of Marlborough District of Cheraw having till lately resided in this County – That she is the widow of Henry Freeman deceased, & that her late Husband Henry Freeman was a Soldier, & did duty as such in the fifth South Carolina Continental Regiment S/ Lam. Benton, JCC

[p 5: A receipt dated June 20 18?9 [3<sup>rd</sup> digit too faint to discern] in the amount of \$60 paid to Lucretia Freeman as an annuitant of the Revolutionary War indicates that she must have applied for and been granted a pension by the State of South Carolina as the widow of a Revolutionary war soldier. Unfortunately, her petition in the papers relating to it no longer exist in this file.]
