Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

State of South Carolina

To the Honorable the President and Members of the Senate of said State

The humble petition of George Sawyer Sheweth

that he is now tottering under the weight of Seventy years, is poor, & in his old age has to bear the infirmities of weakness & pain of a wound he received in the Revolutionary war; Your Petitioner, because he is unable to labor & provide for himself, a wife & one Child, asks of your body the Annual allowance, granted by the legislature to old revolutionists, if the following Services, entitle him to it, –

Your Petitioner in this State, enlisted under General Moultrie [William Moultrie], was stationed at Fort Moultrie, was in the fort when the British Fleet attacked it, and remained in the Fort until after Charleston fell [Charleston South Carolina fell to the British on May 12, 1780]. The bravery displayed by the Americans at this time is known to all, during the whole time of the Conflict from the duties of a soldier I never Shrunk. When Charleston fell I was taken prisoner, & kept in confinement for fourteen Months – during which time I got no other fair than other prisoners, which was such as to teach me, that the British are Cruel to their Prisoners – At their hand I suffered disease, hunger & thirst, – I however at last effected [sic] my escape, and again Joined in the ranks of my Country, & continued to do those duties which I thought were incumbent on me as a Soldier; after I joined the Americans the Second time I was shot in the Head, behind the right ear & since the wound I have lost all feeling in that part of my head – I was at York Town when Cornwallis was captured [October 19, 1781]³ and much other service did I do out of this State, Though I say it myself & Should not boast, yet not many fought more bravely & constantly than myself – I was wounded only one time – were I not miserably poor I would not ask a pension nor would I in poverty had I heart and Strength to labor. I have refrained
