Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]



The Committee to whom the petition of Moses Baker was referred
Report

That they find the petitioner was formerly a Soldier in the first Continental Regiment of South Carolina and was disabled from being of service in the said Regiment by the breach of a Cannon falling on him; that afterwards he in some measure recovered his Strength and joined General Green [Nathanael Greene] before and after the Battle of Guildford [Guilford Court House, March 15, 1781], when he received a kick from a Horse which has rendered him unable to procure his livelihood by his manual labour –

The Committee therefore recommend that the same allowance the made him by this State; as to other disabled Soldiers –

Resolved that this House do agree with the Report

Ordered that the Report and Resolution be sent to the Senate for their concurrence By order of the House

Ann in the year 1792, Elizabeth in the year 1791, Moses in the year 1790 and Zilpha in the year 1796. — And she further swears that she is not possessed in her own Right of any Lands or Negroes.
