Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

The humble Petition of your Petitioner Thomas Gibbs Senior Sheweth that he was a soldier for seven years in the Service of the United States in the Revolutionary War and Spent much of the prime of his life in the Service of his country that he is now very old, and in very reduced Circumstances and almost blind and is in need of assistance for his support therefore [he] hopes his case will be taken into consideration and prays that he may be put on the pension list and in duty bound he will ever pray

Report

That they have examined the same and find That Thomas Gibbs deceased was on the Pension List of this State at sixty dollars per annum. They further find that the said Thomas Gibbs drew his Pension as appears by his receipts in Treasurer's Book on the 30th of March 1821 and it is stated in the Petition that he died on the 6th day of April [year obliterated by an ink blot but must have been 1821] leaving but six days between the period of his death and the date of his receipt. They therefore recommend that the prayer of the Petition be rejected
