I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

Personally appeared Lieutenant John Bouchillon [sic, the signature is by Joseph Bouchillon], Peter Rogers [sic, the signature is by Pierre Roger]³ and Andrew Gillebeau of said District who being duly Sworn to value a Gun Shot bagg & bridal the property of Lieutenant Pierre Gibert lost in the public Service. They the said Peter Rogers, John Bouchillon & Andrew Gillebeau value the said articles at One Hundred & fifty Pounds [old South Carolina] Currency. The said Peter Rogers further adds that about the beginning of February last Lieutenant Gibert & he being upon Duty they were beset in the night by a party of armed men who plundered them of their Arms &c. as above specified.
