The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

N. B. The 265 days charged are not mentioned when the duty commenced or ended, he has an Account in No. 50 4 duty as Private previous to the reduction of Charleston Amounting [to] £32.10 Currency or £4.12.10 ¼ Sterling.

[Note: Notwithstanding the note above, I am not convinced that the 2 claims were made by the same soldier. I think it unlikely based on having read a large number of the Accounts Audited that the same soldier would have claimed separately for services rendered at the same time.]
