[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

To the Honorable President and other Members of Senate

The Petition of George Gill Executor of the estate of Colonel Archibald Gill deceased in behalf of Robert M Gill, and Mary D Gill, heirs of the said estate, humbly Sheweth. That whereas Archibald Gill deceased possessed of a tract of land Containing one hundred seventy Acres situate in Chester District on the Catawba River, which land was originally granted to Thomas Morris, as compensation for his services as a soldier in the Revolutionary war, by said Thomas conveyed to Peter Jones, and by said Peter to said Archibald deceased for which was paid a valuable consideration. But in as much as the original Grantee had laid his bounty Warrant on lands previously granted to the Catawba Company, your petitioner has been forced to surrender the just right of his testator to the senior grant of said Company.

Your petitioner therefore hopes that the Legislature of his Country will not suffer orphan Children, who are the Legal Representatives of an old Soldier's claim to be thus deprived of their just rights, but will grant to them such relief as they in their situation require And that a just Legislature will cheerfully grant, And your petitioner as in duty bound will ever pray.
