Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

the time – sent by General Williamson [Andrew Williamson] to General Ash [John Ashe] who had the command at that place & time. Sworn to & subscribed this 15<sup>th</sup> December 1823 Before

The State of South Carolina

To the Honorable the Speaker & Others the Honorable Members of the House of Representatives in the Legislature of Said State Greeting –

The Humble petition of Elizabeth Gilmore Sheweth unto your Honorable body that her late Husband James Gilmore deceased faithfully served as a soldier in the State Troops in the Revolutionary war and was honorably discharged, that a warrant for Military bounty land was issued in his favor for one hundred eighty acres of Land as a compensation for his services that he had the said Warrant Located in the District of York on a plat of prime Land which he at that time [several words of text to faint too discern] afterwards supposed & believed to be vacant at the time, but since the death of the said James Gilmore your petitioner has discovered that the said Tract of Land is included in a large [text to faint too discern] of older date that was Granted to the Reverend Thomas Harris, [text to faint to discern] & Thomas Black, that they & those claiming under them have had possession thereof for many years, your petitioner further states that she is poor, aged, & infirm and destitute of any means of support, that this tract of Land was all that her deceased husband was able to leave her for her support which would have been sufficient to make her few remaining days comfortable the Land being valued by the good judicious Neighbors at ten dollars per acre and some of it has actually been Sold at sixteen dollars per acre, your petitioner further States that she has submitted her papers with all the facts of the case to an attorney at Law by whom she was advised that there is no possible chance of her recovering said tract of Land – Your petitioner therefore prays that the Legislature in the exercise of its [undeciphered word] liberality & Justice will Grant to her such compensation or

<sup>&</sup>lt;sup>4</sup> In Samuel Johnson's Dictionary of 1755, the first definition of the word "meet" he gives is "Fit; proper...." Johnson noted that even at that time the word "meet" was rarely so used. It must have become fairly popular in South Carolina in the early 1800's, however, as it appears in many petitions submitted to the SC Legislature.
