The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]



I David Glyn of Ninety Six District do hereby assign transfer & set over to Mr. William Steel of Charleston Shopkeeper all my Estate Right and Title & Interest in & to all such sum or sums of Money now due & owing to me by the Public of this State (Accounts for which amounting to about Two Thousand & fifty-eight pounds old Currency or thereabouts are now delivered into the Auditor's office & under Examination in order to their having passed) together with all my Estate right & title in & to the said Account & all the Vouchers for establishing or Securing the payment of the said Sum of Money [undeciphered word] and Owing me as aforesaid. And I do hereby Constitute make & appoint the said William Steel my true & lawful Attorney irrevocable for receiving taking & demanding full me & in my name the said Sums of Money aforesaid & on Receipt of the Same Sufficient Release Receipts & discharges therefore to give Execute Seal & deliver. Witness my Hand & Seal at Charleston the 17th of April A.D. 1784 S/ David Glyn
