Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

A Just and true Pay Bill for James Gore Senior for his waggon and Teem which was Prest [Pressed] at Charles Town [Charleston] the Eighth Day of March 1779 and put into the Continental Sarvis [Service] and Served until the Twenty-fourth, and then was Prest by Mr. Samuel Night [sic, Samuel Knight] waggon master Jinoral [General] and served until the 3<sup>rd</sup> day of May in 1779, and then one Hors [horse] either Died in the woods or ran away and the waggon was unfit for Duty the other three Horses was put in the Care of Mr. Zachariah Robards and in his Care another of the Horses Died or got Lost so that I never received but Two of my Horses and the Waggon is lost entirely from my Service
