[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

Foote: 112-116, 119, 120, SchV:55, M:274, privateer man of war of 40 guns, 1355 tons, manned by 540 men, which left the Texel (the Netherlands) on 25 August 1781, with SC Navy Commodore Alexander Gillon in command. This vessel was the property of France, originally the *Indien*, built in Holland, loaned to the State of South Carolina for 3 years for privateering. It took part in the Spanish/American capture of Nassau in 1782, under Capt John Joyner. The ship was taken by the British in Sep 1782, and crew sent to prison in New York. One of its prizes was taken Sep 1781 and one of its prize crew sent to Mill Prison. (Clark:I:138 shows her captured 19 Dec 1782, by the British *Astrea, Diomeda, Quebec*. The ship is said to have arrived in New York on 24 Dec.) Ford1782:309, 632, 703, Ford1784:332. JA6:295, 9:491. CTN:58. CTP:123. The Memorial of Richard Graham Humbly prayeth

detained a Prisoner until the Peace.

That your Memorialist, conceiving himself entitled to some Compensation for Services performed on board the *South Carolina* Frigate under the Command of Commodore Alexander Gillon, and Captain John Joyner, in the Capacity of Master of Alarms, with the pay of Five pounds per month in which Station your Memorialist was severely wounded, in the year 1781 when lying in the harbor of Corrunna [Corunna] (in Spain) in assisting to Quell a mutiny on board said Ship: the wounds which he then received (being on his right arm, near the wrist which cut the Sinews thereof) has rendered him incapable of pursuing his occupation, viz.: That of a Scrivener: As also three other wounds on his left shoulder, two of which were with a Sword, and one with a Bayonet, which renders him incapable of following any other Calling. Your Memorialist further state to your Honorable Body, that he has continued in the Service of this State on board said Ship until she was taken and carried into New York Harbor, and there

Your Memorialist beg leave to inform your Honorable Body, the reason why he did not make application before in his situation of disability, was from a wish to be as little burdensome to his Fellow Citizens as possible, more especially being not in want, having received an appointment as Gunner at Fort Johnston in the Harbor of Charleston South Carolina, where your Memorialist continued in the Service of the State, until it became a Federal Post. —

Your Memorialist's disability prevented him entering into Actual Service – Your Memorialist pray your Honorable Body to grant him such relief as his Situation demands, and which he conceives he has a claim. – Your Memorialist with due submission [image at the bottom of the page ends here]

pray [one or more words too faint to discern] your Honorable Body, that his request is not unprecedented, viz.: John Young who was wounded in that ever memorable Action of Fort Sullivan in the year 1776, under the Command of that Venerable Officer then Colonel, now General William Moultrie. —

And your Memorialist lastly prays your Honorable Body to grant him every other relief in the premises, which to you, shall seem meet, ³ or which he may be entitled to.

³ In Samuel Johnson's Dictionary of 1755, the first definition of the word "meet" he gives is "Fit; proper...." Johnson noted that even at that time the word "meet" was rarely so used. It must have become fairly popular in South Carolina in the early 1800's, however, as it appears in many petitions submitted to the SC Legislature.

To the Honorable Theodore Gilliard Speaker & others the Members of the House of Representatives

The Memorial & petition of Richard Graham,

Sheweth

That your memorialist having served during the late American War, on board the South Carolina frigate commanded by the lake Commodore Gillon, and Captain John Joiner, both in Europe and America, in the several capacities of Master of Arms & Gunner, as will appear by the Portage Bill book, in the office of the Comptroller, your Memorialist further Sheweth, to your Honorable House, that a large balance is still due, and owing to him by the said State, for his Services on board the said frigate, He further Sheweth that he is legally entitled to prize Money arising from the captures of the following Vessels, (Videlicet [Viz.]) a Brigantine from Newfoundland, laden with Codfish and which was carried in, and sold in Teneriffe [Tenerife]⁴, and purchased by Mr. Augustine Buyck, who Sent her to Cadiz. Three Ships, and Two Brigantines, from the Island of Jamaica from the port of Glasgow, and which were carried in and sold in the Havana, Your Memorialist is also entitled to a further share of prize money in behalf of the late George Patterson (Masters Mate) also William Lardner, Richard Cain, & John Callaghan who served as Seamen on board the said frigate on whose estate your Memorialist has duly administered, Your Memorialist prays that the respective principles, and the interest due respectively thereon, being ascertained, and your Honorable House, being satisfied of the Justice of the several claims, herein before Stated, by a reference to the portage bill, Such provision will be made for the liquidation, and payment thereof, as to your Honorable body shall Seem equitable and Just – You will Memorialist beg leave further to state, to your Honorable House, that he is disabled in consequence of Severe wounds in the right arm, received on board the said
