Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

What I think I can extract from it is that the veteran claimed service for 30 days duty at 20 old South Carolina shillings per day and 30 days service at 10 shillings per day totaling £45 in old South Carolina currency or £6.8.6 <sup>3</sup>/<sub>4</sub> Sterling. Twenty shillings per day was the pay rate for a mounted militia man providing his on horse and ten shillings per day was the pay rate for a militia man serving on foot.]

[p 4: Printed form of Indent No. 308 Book L dated October 16<sup>th</sup>, 1784 "delivered to Mr. Christopher McCarter this our Indented Certificate for the Sum of Six Pounds Eight Shillings and Six Pence three farthings Sterling for 60 days Militia duty in 1780 and 1782 as per Account Audited."]
