Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

Personally appeared before me one of the Justices of said County – James Martin and made oath as the Law directs, and Saith, that Samuel Barkley of said County, did fifty-five days Militia duty in Colonel Bratton's [William Bratton's] Regiment in the year 1779 – in the months of February and March in Captain Kirkpatrick's [John Kirkpatrick's] Company and the detachment was Commanded by Major Francis Ross, and as the field officer that commanded the said Regiment was dead at the time of Auditing Accounts in this State the said Barkley says that he cannot get his claims passed in an Indent, I hereby Certify that the said Barkley did the above duty – and that the said James Martin served in the said detachment as a Captain during the said tower [tour] of Duty
