Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

I Richard when of Winnsborough Esquire, do hereby Assign the full amount of Principal and Interest as now due and to grow due on the within Certificate, (& which I have purchased of the within named William Gray, as appears by his order now lying in the office of the Commissioner of the Treasury) unto William Lennox of Charleston Merchant his Executors Administrators & Assigns, full value received from the said William Lennox this 25th day of July 1785 Witness

William Gray's Indent No. 161; O, for Sixty six pounds 8/9/Sterling, for Duty as Private & Lieutenant under Captain Joseph Calhoun, & under Colonel Anderson's [Robert Anderson] Also for a Mare lost – was received from the Treasury by Minor Winn by Virtue of an Order from another Man of the same name who did Duty under Captain Martin in Colonel Richard Winn's regiment & whose account amounts only to £56.6.6 and still remains in this Office
