[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

To the Honorable, the Senate and House of Representatives,

Whereas, the humble petition of Edi Red of the State & District aforesaid, humbly Sheweth to your Honorable bodies that she is the lawful wife of Job Red, who has lately died, and who was enrolled for the last twenty years before his death, as a State pensioner, for Services rendered as a Revolutionary Soldier. – By his hand, the said Job Red, and myself, underwent many privations and hardships during the old war, – during which time we had our houses burnt and everything we possessed in the world, – And also, my husband, the said Job Red, was badly wounded by the Tories, – which wound rendered him unable to do any bodily labor so long as he lived &c – Your petitioner is left quite poor and destitute of any property to Support on. – My friends and relations are not able to assist me in my old days, – I am very infirm: not able to do any sort of business, – I am Some eighty odd years old. – It is therefore hoped that your Honorable bodies will take my Case into Consideration, and make me a pensioner during my natural life, – And as in duty bound, Your petitioner will ever pray &c

Personally appeared, John Wise and made oath that – he was acquainted with Job Red, & that he was regarded as a married man in the War of the Revolution, and his wife's maiden name was Edi Bently. – This deponent further says that Job Red was wounded by the Tories so said in the Revolutionary War, & that he saw his wife with him for the purpose of administering to his wants & necessities. – This deponent moreover says, that he was acquainted with Job Read as long as he lived, & that he occasionally visited him during his life & that he was living with Edie, the woman that was said to be his Wife in the War of the Revolution. – This deponent further Says, that he did not see Job Red & Edie Bently married, but from common report, believes that they were married in the War of the revolution
