Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undecipherad' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

To the Honorable President and others the Honorable members of the House of Senate of the State of South Carolina

The Humble Petition of Widow Jennet Glen Sheweth

That your Petitioner is the Widow of William Glen, who was taken Prisoner at Briar Creek [March 3, 1779]<sup>2</sup> when in service of America (under the command of Major Ross [Francis Ross] of Colonel Neel's [Thomas Neel's] Regiment of Militia) and died in confinement, leaving your Petitioner in a helpless situation with six small Children all of whom are now grown up: that thro' the goodness of the State She has hitherto received a Pension or allowance to her great comfort and relief, which has been paid except part of the last Years, but understanding when she last sent to the treasury for said arrears that no more would be paid, without application being first made by Petition to the Legislature.

Your Petitioner therefore humbly suffocates a continuance of said Pension and that your Honorable House would give Orders for the regular payment of the same, that she may be better enabled to subsist with some comfort. And she as in duty bound will ever pray.

Report

That they have examined the Books of the Treasury and find that five pounds are due to Ms. Glen as her pension for the year 1793 and recommend that the Treasurer in Columbia be directed to pay the same.

Resolved, that this House do agree to the Report

Ordered. That the Report and Resolution be sent to the House of Representatives for their concurrence

The petition of Jenat Glen Humbly Sheweth

That your petitioner's Husband was killed in the late war fighting in defense of his country. She therefore prays, that your Honorable House would take her case into Consideration and Grant her the pension allowed by law in your petitioner as in duty bound will ever pray.
