Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. To the Honorable the Speaker and members of the House of Representatives of the State of South Carolina

The petition of William Trammel a revolutionary pensioner Humbly Sheweth That you will pensioner was wounded near Broad River in South Carolina in the year 1781 in the defense of this State and was placed on the pension list at an early period after peace took place with Great Britain. Several years has passed that your petitioner did not draw the annuity allowed him by Law which may be ascertained by searching the Books and Receipts in the Treasurers Office

Your Petitioner therefore prays your Honorable body to take his case into your serious consideration and grant him such balance of his annuities as may appear due to him on the search aforesaid war such other relief as your Honorable body may deem Just and right in your petitioner as in duty bound will ever pray

November the 8th 1820 S/ Wm Trammel, X his mark
