Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.]

To the Honorable the President and Members of the Senate of the State of South Carolina &c The humble Petition of Charles Lehoux French of Nation and Ancient Captain of Sea humbly Represent

That by the effect of his Zeal for the Americans in the year 1777 he came in this State with a Schooner by which he Brought here a Considerable Cargo of merchandise

That the said Cargo having been Sold he sent at Sea from this part his said Schooner for to Guard, Fitch more Suply [Supplies] again for this place but his said vessel was taken by the Englishs [sic]

That this Geal [sic] grat [sic] Loss of your petitioner was unhappily increased by the depreciation of the papers Money and to such a degree that your petitioner has never been able since to Relieve himself

Never the less your Petitioner did not lose his Zeal for your Cause or Strunggle [Struggle] but he accompanied you in the two Last Siege of Charles ton [Charleston] and he can boast himself to have given the first fire of Cannon against the Fort that Clainton [Sir Henry Clinton] had ericsed [erectedin the North of this City So as he Can produce credible witness

Finally your petitioner having been made a prisoner at the Surrendering of this place [Charleston South Carolina fell to the British on May 12, 1780] and been obliged to be Carried to north wards for his exchange and from this last disturbance having been totally cast out and ruined he throw himself in the arms of your Tenderness and Commiseration imploring your Services for to help him to Relieve from the burden of distress and mesery [misery] by any means in your power for the said Purposes –

Your [indecipherable word] honorables Gentlemen and fathers of the people with the thanks fully acknowledged and your Petitioner by Duty bound to you will ever Pray

To the Honorable John Lloyd President [text too faint to discern ] South Carolina

The petition of Charles LaHoux [sic] of the City of Charleston – Humbly Sheweth – That your petitioner have been Resident of this State ten years and during the War Contributed as much as in his power to the defense of this City during the Siege. That on the Capitulation your petitioner was confined in the [text too faint to discern] he suffered great hardships.

That your petitioner on his arrival in this State was Master of a Schooner in part laden with ammunition and in part with dry goods, all which he disposed of to the public for the paper money of this State then in Currency – That by the depreciation seventy-five thousand Dollars (the amount of said Cargo) was reduced to a very small value.

That your petitioner being in a State of distress and unable from his Age and Infirmities to support himself by manual labor, hath been under a necessity of becoming a Keeper of a Billiard Table as the only resource now left him in the close of his days to prevent him from being a public burden begging in the Streets or from starving. That under the laws of the Corporation your petitioner is subject to a Tax of £50 yearly which with the same annually payable by your petitioner for his hire of said Table, are insufficient to provide the Common Necessaries of Life, will [undeciphered word] your Petitioner's hands.

Your petitioner (in consideration of the heavy loss he sustained, his infirmities, his age and inability to Earn his Support by any sort of [undeciphered text] said tax in favor of your petitioner.
