Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

Humbly Sheweth that your Petitioner in the late Revolutionary war with great Britain distinguished himself as a friend to the American cause of Liberty & in the month of February 1781 Under the Command of Brigadier Genl. Sumpter in Capt Saml Adams Company he was Severely wounded and taken Prisoner and by Reason of which Your Petitioner is Rendered Unable to make A livelihood and has Never Received more than one years Pension –

Your Petitioner Begs your honorable body to take his case under Your Serious Consideration and grant him such relief as in your Wisdom Shall think meet and Your Petitioner as in duty bound will ever Pray

York District} Personally appeared James Harbison before me the Subscribing Justice and Made Oath according to Law, and Saith that in the Month of February 1781 he the deponent was Under the Command of Brigadier Genl. Sumpter in Capt Adams Company at Wrights Bluff⁵ in an engagement with the enemy he was Severely wounded & taken prisoner that being at this time far advanced in Years And in Consequence of said Wounds finds himself unable to make a livelihood, and Only has a piece of land of small-cap value & slave. Sworn & subscribed to this 15th of November 1800

The Petition of James Harbison Humbly Sheweth that your Petitioner in the Revolutionary war with Great Britain distinguished himself as a friend of the American cause of liberty and in the year 1779 in the month of Feb^{ry} being under the Command of Brigadier General Sumpter in Captain Sam¹ Adams Company at Wright's Bluff was dangerously Wounded and taken Prisoner by Reason of which wounds Your Petitioner finds himself unable to make A livelihood and having no Negroes
