Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

The petition of Samuel Gruber humbly sheweth, that your petitioner, presents you with a statement of his account, current, with this State, enclosed – by which you will find that although he has been paid several small sums yet by his account certified by the Honourable John Rutledge & Christopher Gadsden Esquires & Mrs. Sarah Rutledge a balance will be found in his favor of One hundred & Seventy four pounds 11/3 which with Interest, to this date amounts to Two hundred & Seventy nine pounds 3 Shillings & 3d – This sum your petitioner humbly hopes, your Honours will grant him an Indent for your petitioner's great losses of property during the War, - & his present indigent situation will he hopes meet with your Honours Commiseration so far as to pay attention to the justice of these claims, by granting him that compensation which he considers his labours merited – & your petitioner will ever pray.

I do certify that Samuel Gruber was sent by General Lincon [Benjamin Lincoln] & by me on several expeditions between the months of April 1779 & 1780 for Public Service but cannot ascertain the number Signed J. Rutledge [John Rutledge, Governor]

When I commanded in Charleston from 13 April 1780 as Lieut. Governor until 12 May following Mr. Gruber was employed by me as an express rider & I believe by General Lincon till the capitulation, which I do now certify this 30 Day of April 1784 Signed Christopher Gadsden

Mr. Gruber has this day delivered unto the Commissioners Office for settling the Public Accounts the original of the above Amount

Samuel Gruber being duly Sworn made oath that the within Account is Just and true and that the two Horses Charged [word obliterated and rendered illegible] were truly his own property and absolutely lost in the service whilst he was employed as Express Rider in behalf of this State by the Governor John Rutledge Esquire and General Lincoln & that the Horse [words interlined and illegible] lost at Mrs. Rutledge's was [several words to faint to discern] he being obliged to quit [undeciphered word] take [several words undeciphered] the British.
