I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

Samuel Hammonds [Samuel Hammond's] Regiment of State Troops this our Indented Certificate for the Sum of Ninety-four pounds Sterling being the Balance of Pay and Bounty due him for Services done in that Regiment Together with Interest thereon from the first April 1782 to date hereof Agreeable to Resolution of General Assembly of the Eleventh March last &c."]

[p 5 (retake of page 4): The reverse of the above Indent bearing, among others, the following endorsement:

Received the 6 March 1787 from the Commissioners of the Treasury Ninety Six pounds Fourteen Shillings and Nine Pence Sterling in full for the principal and Interest on the within Indent to this day by discount on my bond for forfeited property – Say on John Guiland's $[?]^2$ bond. £96.14.9
