Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8<sup>th</sup> of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

The State of South Carolina

To the Honorable the Speaker and Members of the House of Representatives of the State aforesaid

The Petition of James Halliday humbly Sheweth

That your Petitioner in the month of March 1794 purchased an annuity certificate of Ann Windom Widow of John Windom late of Orangeburg District who was taken by the British in the War with America and kept as their prisoner until his death but the said Ann Windom not having been heretofore placed on the Pension list your Petitioner hath not been able to draw the said Annuity in pursuance of the Said Certificate & Your Petitioner further Sheweth that your Petitioner and his Brother John Halliday was on the first day of December in the year 1793 and for some time before and afterwards in copartnership in Trade as Merchants that the said John Halliday Sometime in the Said month of December Purchased one other Annuity Certificate for and in behalf of the copartnership of one Elizabeth Daley widow of Alexander Daley late of Newberry County who was killed in the late War between America and Great Britton your Petitioner therefore most humbly Prays that your Honorable House will place the said Ann Windom & Elizabeth Daley on the Pension list whereby your Petitioner may be enabled to draw the annuities aforesaid of the said Ann Windom and Elizabeth Daley annual Petitioner as in duty bound will ever pray



[Note: The legislative committees that examined this claim stated that the legislature could take no action on the petition unless and until Ann Windom & Elizabeth Daley filed for and were
