Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention.1

To the Honorable John J Pringle Esquire Speaker & the other Members of the Honorable House of Representatives

The Petition of Henry Weems humbly Sheweth

That your Petitioner was wounded & lost a Leg in the year 1776<sup>2</sup> in an action with the Cherokee Indians. That the Legislature granted to your Petitioner an annuity of 90 pounds Currency per annum. That your Petitioner had then a small Family which is greatly increased having now seven small Daughters – & sometimes unable to provide for them. That in addition to your Petitioner's misfortunes said annuity has of late been reduced as he is informed to five pounds a year & forty Shillings to every child that was born at the time previous [?] My [being?] wounded or disabled. Your Petitioner begs leave humbly to represent that his unfortunate children born since his wound are not less objects of compassion than those born before – and equally [indecipherable word] their wants as he cannot disabled as he is follow his Plow & provide a maintenance for them.

Your petitioner humbly prays to grant him such relief as in the wisdom & humanity of your honors house he may seem to deserve and Your Petitioner as in duty bound will ever pray

[Note: The South Carolina General Assembly reinstated the full 90 pounds [South Carolina currency equal to 12 pounds 17 shillings Sterling] annuity. The file contains annual affidavits from the veteran stating his continued disability up to 1799. In each of the affidavits, they the veteran states that he owns no Land but owns one Negro (not named).]
