Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

Pursuant to an Act of the General Assembly passed the 16th March, 1783, and Resolution passed the 15th December, 1792, I have this Day delivered to James Hartley this INDENTED CERTIFICATE for the Sum of Five hundred and fifty two Pounds five Shillings and eight Pence, Sterling, being for part of the Estate of Robert Williams the Elder deceased and sold as the Property of Robert Williams the Younger by virtue of an act entitled "an Act for disposing of certain Estates, and banishing certain persons therein mentioned, dated the 26 day of February 1782 the same being Restored, by a Resolution of the Legislature dated the 15 December 1792 as before recited, to the said James Hartley for himself and the other Devisees of the last Will & Testament of said Robert Williams the Elder deceased.

The said James Hartley

his Executors, Administrators or Assigns, will be entitled to receive from this State, the sum of Five hundred & fifty two Pounds five Shillings & eight Pence bearing Interest thereon, at the rate of Seven per cent, per Annum, from the 15th day of August one thousand seven hundred & eighty two –

For the true performance of pavement, the PUBLIC TREASURY is made liable, and the FAITH of the STATE pledged by the aforesaid Act.
