I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

Samuel Hammond's Regiment of State Troops this our INDENTED CERTIFICATE for the Sum of One hundred and forty one pounds Sterling being the Ballance of pay and Bounty due him for Services in that Regiment Together with Interest thereon from the first April 1782 to date hereof Agreeable to Resolution of General Assembly of the Eleventh March last &c."]

² "Sumter's Wages" Volunteers serving in Genl. Thomas Sumter's 10-month State Troops were promised 'wages' in the form of slaves confiscated from Tories (Loyalists). The horrific form of payment was known as "Sumter's Wages." When an insufficient number of slaves were taken from the Tories to pay these wages, the Legislature issued Indents in pounds Sterling deemed to be the equivalent of the value of the promised slaves.
