Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

The State against a negroe man Slave named Jack the Property of David Hay of said District For Horse Steeling and for Deludeing other Slaves to run away and Joyn the English Armey – The Justices and Freeholders being duly sworn agreeable to the act of Assembly: The prisoner was brought to the bar When the Case and Charge against him the Prisoner was fully opened and Explained to him and he was thereupon asked If he was guilty of the felony whereof he stood indicted or not guilty to Which the Prisoner answered not guilty: Where Upon the Court acquainted him that they Were to proceed immediately Upon his triel and Would hear his answer to the Charge against him and what Ever Witnesses he had to produce in his behalf As Well as those against him. The Witnesses Proceeded to support the Charge against the Prisoner as also the witness for him being duly Examined and fully heard the Court after mature consideration found the Prisoner guilty Upon which the said Jack was asked if he had any thing for him Selfe to offer or Could Say Why the Count to Judgment and Execution of him for the [undeciphered word]² ought not to Proceed and he kept saying nothing But What at first he said Upon this then and there

It was considered by the said Justices and Freeholders That the afore Said Jack be kept Safe in the Custody of the Constable of the Said District From Whence he came shall be Sent back and thence be led Unto the Place of Execution and there be Hanged by the Neck Until his body be Ded Ded [sic] -

Ordered That the said Constable Do cose [cause] this Sentence to be put in Execution on the 22nd day of this Ins:[instance] April 1780 Between the Hours of fore and Five Given under our hands and Seals the Day above Written
