Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

This day came Levi Johnson before me a Justice for Sd County and Mead oath and Seayth that he sarved in a Capt. committon in Genel Sumtor's [Thomas Sumter's] Brigade under Coln John Thomas [John Thomas, Jr.] in South Carolina in what was Comonly Called the ten Months Sarvice in the year 1781 untill Regularly Discharged as Supernumerary by Genel Wm Henderson [William Henderson] and doing which time of Sarvice he Never plundered nor felloniosly tuck aney Cash or property from the State or individuals of South Carolina Nor Did he Suffer any of his men Whilst under his Command to plunder any thing to his knowledge and in during the time he was Recruting anumber of men for Sd [text compromised and undeciphered] his own Expense with his own money and that he Roade his own horse Dureing the whole time of sd Sarvice And that he Never has Received any Cloathing Whilst in said Sarvice Nor Since in Consequence Thereof that he Never has Received any pay or Satisfaction for said Service nor for the Mony he Expended in Recruting for sd Sarvice Except one peck of Salt he Recd of Genl Sumptor.
