[Methodology: Spelling, punctuation and/or grammar have been corrected in some instances for ease of reading and to facilitate searches of the database. Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

To the Honorable the Members of the House of Representatives of the said State The humble petition of John Henson Sheweth

That your Petitioner was a regular soldier in the Revolutionary War, enlisted under Captain Patrick Stewart<sup>2</sup> an officer under Colonel Hawkins<sup>3</sup> – That as a regular Soldier under said officers he performed Service for Six months in this State, that by the ravages of the Tories he was stripped of all his property, That he was wounded at the Famous battle fought at an early period in that war, called the battle at Collins Creek,<sup>4</sup> although he performed services as a soldier since his service as aforesaid, in this State under the above Officers, it was [the image of the document posted online becomes largely illegible at this point]

To the Honorable the Members of the Senate of the Said State, Greeting

The Humble Petition of John Henson Sheweth that your Petitioner as a regular Soldier in the revolutionary war, enlisted under Captain Patrick Stewart an Officer under Colonel Hawkins: That as a regular Soldier under Said Officers, he performed service force Six months in this State. That by the ravages of the Tories, he was Stripped of all his property – that he was wounded at the Famous battle, fought at an early period in that war, Called the Battle at Collins Creek, Although he performed Service as a Soldier since his wound as aforesaid in this State under the above officers, it was more from the [undeciphered words] deliver of his Country than from corporal ability to perform. He has ever since been unable for hard Labor, & has heretofore only been able to procure a Sufficiency to live upon & not to support on in his old age. His age (now 75 years old) with the infirmity remaining from his wound as aforesaid render him unable to work, [undeciphered word or words] he is very poor. Your petitioner therefore humbly prays your Honorable body to give him a pension.

The petition of Richmond R Terrell administrator with the will annexed of John Hinson Senior [sic], deceased late of Lancaster District & State aforesaid respectfully Sheweth, That his testator the said John Hinson was a revolutionary pensioner residing in Lancaster District South Carolina at the time of his death, which occurred the 26<sup>th</sup> day of January 1845 – that he died received from the Treasury of the upper Division Julius J DuBose Esquire an order upon the Tax Collector for Lancaster District & which is hereunto annexed & accompanies this petition, for the sum of Sixty Dollars for one years annuity due on the 1<sup>st</sup> March 1845, That after having received said order & before the same was paid by the tax collector, or presented, the said annuitant John Hinson departed this life.

Your petitioner further Sheweth that on the 19<sup>th</sup> February 1845, he qualified as administrator with the will annexed of the said annuitant, before the ordinary of the District & that he as administrator presented the said order for payment to the tax collector of Lancaster District, who refused paying the same, because he conceived that the order would not authorize him to pay to the your petitioner as his administrator, or in fact to anyone, except the annuitant in person.

Your petitioner therefore prays your Honorable Body, to authorize the Treasurer to pay to him, the said sum of Sixty Dollars, being the annuity due his testator John Henson & he will ever pray & repose

November 19<sup>th</sup> 1845
