Where the meaning is not compromised by adhering to the spelling, punctuation or grammar, no change has been made. Corrections or additional notes have been inserted within brackets or footnotes. Blanks appearing in the transcripts reflect blanks in the original. A bracketed question mark indicates that the word or words preceding it represent(s) a guess by me. The word 'illegible' or 'indecipherable' or 'undeciphered' appearing in brackets indicates that at the time I made the transcription, I was unable to decipher the word or phrase in question. Only materials pertinent to the military service of the veteran and to contemporary events have been transcribed. Affidavits that provide additional information on these events are included and genealogical information is abstracted, while standard, 'boilerplate' affidavits and attestations related solely to the application, and later nineteenth and twentieth century research requests for information have been omitted. I use speech recognition software to make all my transcriptions. Such software misinterprets my southern accent with unfortunate regularity and my poor proofreading skills fail to catch all misinterpretations. Also, dates or numbers which the software treats as numerals rather than words are not corrected: for example, the software transcribes "the eighth of June one thousand eighty six" as "the 8th of June 1786." Please call material errors or omissions to my attention. Researchers should not rely solely on the transcripts but should review the originals for themselves. These transcripts are intended as an aid to research, not to be used in lieu thereof.]

To the Honorable the Legislature of the State of South Carolina The Petition of Frederick Huver [?]² of Dauphin County in the State of Pennsylvania Humbly Sheweth

That Ludwig Herman, Jacob Herman and David Herman Sons of a certain David Herman late of the county aforesaid were enlisted to serve on board the Ship *South Carolina*³ commanded by Commodore Gillam [Alexander Gillon], and in pursuance of their Enlistment did serve on board the said Ship and did also die in the said Service.

That David Herman the Father aforesaid who would by Law have been entitled to the Pay of his Sons aforesaid has also lately died, and constituted your Petitioner his Executor. Your Petitioner begs leave to represent that the Family of the said David Herman is poor and would be

considerably relieved by receiving the Pay to which the young men before named would have been entitled.

Your Petitioner has indeed been informed lately that Claims on the State of South Carolina for Services on board the Ship aforesaid our barred by an Act of Limitation; but Your Petitioner would beg Leave to represent that the aforesaid David Herman the Father did live in the interior Parts of the State of Pennsylvania, at least one hundred Miles from the City of Philadelphia and Your Petitioner verily believes that the said David Herman never heard of any Act of Limitation but expected from time to time to receive the Pay of his Sons, without knowing or considering of the Channel through which he should obtain it.

Your Petitioner therefore prays that such an Act may be passed as will enable the Family of the aforesaid David Herman to receive the pay of his Sons aforesaid & he will pray.

On the 4th Day of July in the Year of our Lord, 1804 came before me the Subscriber 1 of the Justices of the Peace in and for Berks County Michael Spatz⁴ and John Fox⁵ both of the Borough of Reading in the County aforesaid and who being severally sworn on the Holy Evangelists of Almighty God do severally depose and say that they were enlisted and served on Board the Ship *South Carolina* commanded by Captain Joiner [John Joyner] that they sailed with him from Philadelphia and were on board said Ship when she was captured, That a certain Ludwig Herman, a certain Jacob Herman and a certain David Herman also served on board said Ship and were on board when she was captured, That each of the said Deponents knew the said Ludwig, Jacob & David well and further say that after the Capture aforesaid they these Deponents and the other Prisoners were confined on board a Prison Ship near New York, that the said Ludwig, Jacob, & David were also confined in the said Prison Ship and in the same each of them died.
